



Senior Financial Analyst

As a Senior Financial Analyst, you will have the opportunity to apply your financial and analytical skills to support meaningful projects and initiatives that contribute to the betterment of Virginia. We're looking for a team player who is driven by purpose, eager to tackle complex financial challenges, and committed to positive outcomes.

Essential functions of the position include:

- Conduct thorough analysis of loan requests, including revenue projections and risk evaluations, and prepare comprehensive reports
- Present credit recommendations to VRA credit committee and, as necessary, the VRA Board of Directors
- Enable information sharing with applicants and state agency partners, through due diligence calls, on site tours and status meetings
- Facilitate loan closings, including coordination with the transaction team and review of financing agreements, exhibits, and other closing documents
- Assist with the management of revolving loan fund bonds, including new issuances, continuing disclosure, bond indenture requirements, and instructing activities conducted by the trustee
- Maintain financial models for revolving loan fund programs concerning debt service coverage, program capacity modeling, and investment decision-making
- Assist with the management of investments and cash equivalents across VRA, inclusive of directing investment funds to investment managers, compliance monitoring, performance benchmarking, quarterly reporting, and meeting ongoing liquidity needs.
- Mentor and train new staff
- Support marketing and outreach efforts for participants in VRA programs
- Stay updated on industry trends, regulatory changes, and best practices in public finance
- Assist the Director of Financial Services in other program needs as required

Specific qualifications include:

- Bachelor's degree in finance, accounting or business-related field
- MBA or Master's degree in finance or business-related field preferred
- Minimum of five years of related credit analysis or loan structuring experience (governmental experience preferred)
- Proficient in Microsoft Word, Excel, and PowerPoint
- Experience with DBC Finance preferred

Knowledge and skills:

- Strong attention to detail and accuracy
- Ability to prioritize and meet deadlines
- Advanced knowledge of public finance and/or public policy
- Strong problem-solving skills
- Ability to research and analyze financial data and convey technical ideas effectively
- Familiarity with loan documentation using common loan structuring
- Ability to interpret interrelated factors and overall effects related to issuing credit

- Experience creating, maintaining, and interpreting complex financial models
- Strong familiarity and ability to interpret financial statements
- Ability to communicate effectively, both orally and in writing
- Experience negotiating loan structuring and terms with counterparties of varying complexity
- Establish and maintain collaborative working relationships with team members and external stakeholders
